## CHILD WELFARE: REPORTING ON THE PROGRESS OF IMPLEMENTING RECOMMENDATIONS FOR IMPROVEMENT



In 2006, we issued our report, Strengthen the Commitment: An External Review of the

Child Welfare System. It contained recommendations to improve the administration of child welfare in Manitoba. All the recommendations were accepted. The Minister of Family Services and Housing announced that follow-up report cards would be done by the Ombudsman.

On July 16, 2008, our first progress report was released. We found that many of the changes that had been implemented have not been in place for a sufficient time to determine if they have had a measurable impact at the front lines of service. There were also basic issues identified in the 2006 report that have not yet been resolved.

#### BRINGING PUBLIC SCRUTINY

On July 24, 2008, the Ombudsman released her Annual Report for the 2007 calendar year. Some highlights were:

Under The Ombudsman Act.

In 2007, investigations by the Ombudsman identified cases where concerns about the incarceration of inmates living with mental illnesses or mental disabilities continue to exist. Ombudsman has taken the position that resolution of issues affecting high risk, high needs inmates, requires the collaboration of the Departments of Health; Family Services and Housing; and Justice.

Under The Freedom of Information and Protection of Privacy Act.

In five access to information cases, the length of time the applicant waited for a response from Conservation was so wrong and unfair that the Ombudsman recommended the Department refund to the applicant the search and preparation fee of \$840. The Department refunded the fees.



Under The Public Interest Disclosure (Whistleblower Protection | Act

This was the first reporting year for the Ombudsman on her mandate under this legislation, which became law on April 2, 2007. Her duties include the handling of requests from government to be exempted from organizations requirement of having a designated officer to deal with disclosures of wrongdoing under the Act. The Ombudsman denied 60 such requests and approved 39 on the basis that these were smaller bodies for which it would not be practical to have a designated officer. Another duty of the Ombudsman under the Act is to receive disclosures of wrongdoing. Three disclosures were received in One was investigated under the Whistleblower legislation and two were more appropriately investigated under *The Ombudsman* Act.

#### SAFETY TIPS FOR YOUTH ON THE INTERNET

This summer, with the assistance of a Masters of Public Administration student from the joint University of Manitoba and Winnipeg program, our office has been augmenting our presentation materials for Ombudsman school visits. This has included consideration of young people's online safety.

Online activities are traceable and may put the user at risk. Here are ten internet tips for youth:

- 1. Guard your personal information
- 2. Protect your friends' personal information
- 3. Be selective with pictures you post
- 4. Don't post specific plans or activities online
- 5. Safeguard your password
- 6. Talk to your parents/quardians before purchasing anything online
- Only add people you know "in person" as a friend when social networking
- 8. Be wary of people you meet on the internet
- 9. Never have direct contact with a person you have only met on the internet, unless a parent/guardian or trusted adult is present
- 10. Talk to your family, teachers and friends about internet-related risks
